Spiritual Direction Training

I completed the 4-year spiritual direction training offered by the Living Well Centre in Melbourne (www.livingwellcentre.org.au) and accredited by AECSD, at the end of 2021. I have also previously completed a 1-year spiritual companionship course in 1999 with the same group.

Professional Experience

I am a trained psychotherapist and family therapist who worked for a Child and Adolescent Mental Health Service for over 26 years, 24 of these as the clinical manager of the southern country service spread over several regions in SA. I also managed this organisation based at Flinders Medical Centre for one year during the director's leave.

Since my retirement from this public service role, I have worked part time as a private practitioner as part of the Adelaide Trauma Centre Group and offer private clinical supervision as part of my practice. I am accredited by Open Arms, (Dept of Veteran Affairs Counselling Service) to provide supervision for their staff. I also see a number of people for spiritual direction and participate in peer supervision related to this quarterly. I also regularly attend my own professional supervision.

This year I have also been invited to provide group supervision as one of 4 supervisors for students in the Professional Pastoral Supervision Course run by the Adelaide based Uniting College of the Uniting Church.

Approach to Supervision Practice

I am trained in a number of models of supervision and have been part of developing internal procedures guiding CAM HS supervision practice. I believe supervision is critically important to encourage self-reflective practice and ongoing learning, as well as to meet accountability and ethical practice standards.

I believe the role of a supervisor is to develop a trusting contractual relationship in which the supervisee feels safe to explore things they are finding troubling in their work or in their personal reactions to others, ethical dilemmas, their hopes and vision for their role, learning edges and any personal blockages getting in the way of their responsibilities or what they wish to achieve.

Within a spiritual setting this is able to be deepened to jointly acknowledge the leading and nudging of the Spirit in this process of reflection/learning, and the shaping of the way in which a priest feels led to lead their parish. I seek to encourage awareness and purposeful use of a supervisee's skills and gifts or particular aptitudes while also enabling exploration of ways in which they can draw on colleagues' different abilities to supplement their learning or broaden the effectiveness of a team or community (or parish). I am deeply informed by my own faith and spiritual learning over many years, as well as by my therapeutic training.

However, I am also clear that supervision is different from therapy (and also from spiritual direction) and retains a focus on the work setting and the experience and aims of the supervisee within this setting. Exploration of personal issues impacting on this work setting and the supervisee's use of themselves within their work, must be negotiated and undertaken with permission. Having been trained in systemic family therapy and its application to wider systems I am also attentive to the context and the dynamics within which a supervisee works and aim to help them clarify the impact of these broader organisational or social issues on their practice.

I have a good knowledge of legal requirements in relation to child protection, family violence, safe work practice, and human services in SA generally, which I believe can be useful in supporting a parish priest engaging with these issues of human life within their parish.
