THE INCORPORATION OF ANGLICARE SA ORDINANCE 2000

<u>AN ORDINANCE</u> to provide for the incorporation of Anglicare SA as an incorporated association under the *Associations Incorporation Act 1985 (SA)* ("the Act") <u>and for other matters.</u>

<u>WHEREAS</u> the Diocesan Council has caused a review to be undertaken of the desirability of Anglicare SA being separately incorporated under the Act and has resolved to recommend to Synod the incorporation of Anglicare SA under the Act.

NOW THE SYNOD HEREBY DETERMINES:

Title

1. This Ordinance may be cited as the "Incorporation of Anglicare SA Ordinance 2000".

Repeal of existing ordinance

- 2. The Anglican Community Services Ordinance 1991 ("the 1991 Ordinance") is repealed.
- 3. Registration as a company limited by guarantee
 - (1) Anglicare SA Incorporated may apply to be registered as a company limited by guarantee ("the company") under the provisions of the *Corporations Act 2001* (C'th).
 - (2) The name of the company shall be "Anglicare SA Limited".
 - (3) The Constitution of the company and any amendment thereof shall not be effective unless approved by resolution of the Synod.
- 4. Indemnity by the Synod

The Synod shall indemnify every member of the Synod who is a member of the company against their liability (if any) to contribute to the property of the company upon the winding up of the company.

3. In accordance with this Ordinance, Anglicare SA shall be incorporated as an incorporated

- association under the Act in accordance with the Constitution annexed hereto as Schedule "A". Vesting of property
- 4. Anglicare SA Inc shall be the successor to the Committee of the Synod established under the 1991 Ordinance and known as "Anglican Community Services" and, later, Anglicare SA, and, without limiting the generality thereof, each of the assets identified in Schedule "B" hereto shall, as at the date of the incorporation of Anglicare SA, vest in Anglicare SA Inc. Implementation
- The Diocesan Council of the Synod shall be authorized to agree, enter into and execute any instruments required to give effect to this Ordinance.
 Amendment of the Parish of Elizabeth (Alteration of Trusts) Ordinance 1981
- 6. Clause 4 of the Parish of Elizabeth (Alteration of Trusts) Ordinance 1981 is amended to read:

"Notwithstanding any other provisions of the said Model Declaration of Trust the Synod shall permit the use of the trust lands by and for the purposes of a body known as "The Anglican Mission Elizabeth" constituted in accordance with the Rules made from time to time by Anglicare SA.".

Date of commencement

7. This Ordinance shall take effect on the date from which Anglicare SA becomes incorporated under the Act
